## **CONDITIONS OF AUCTION – Redland City Council**

- 1. Information on 'party packs' and how to bid form part of these terms and conditions.
- 2. The Auction is being facilitated by Redland City Council (**Council**) on behalf of the charities listed in Clause 10.
- 3. The Auction commences at 12pm on Tuesday 06 October 2015. All bids must be received on Council's news site, via email (events@redland.qld.gov.au) or by calling 3829 8288 by 10am on Thursday 15 October. All bids will be displayed on the Council's news site (<a href="http://news.redland.qld.gov.au/citysliderauction">http://news.redland.qld.gov.au/citysliderauction</a>). Late or misdirected bids will NOT be accepted. Council has discretion to refuse to accept a bid from any person.
- 4. A Bid placed at Auction, either online, by email, or by phone, is an offer to purchase. Once a bid has been accepted by Council there is a binding contract between the bidder and Council to purchase the item at the final bid amount.
- 5. Bidders must be at least 18 years of age. Employees of the Council or of its related companies and agencies associated with the promotion and the immediate families of such employees are not eligible to bid.
- 6.
