Consent Form

Film, photography, recordings and copyright

Purpose of this form

This consent form is to be used when Council staff is required to obtain permission from an individual to use and/or disclose their image or a recording of them, or any copyright material. An exemption to this may be for law enforcement and public safety activities.

Signing the consent form

Council complies with the *Information Privacy Act 2009*. Your image or recording is your personal information. When Council collects personal information it aims to inform you of the reason, how it will be used and who will have access to the information. Your signature confirms that you understand and agree with these provisions.

Individuals under the age of 18 require the signature of a parent or guardian before images or recordings are made of them. Therefore, parents and guardians must sign the consent form before the photo of the minor is taken.

Definitions

For the purposes of this consent form, "I" can also mean "we", and "my" can also mean "our".

Indemnify – to protect against damage, loss or injury. **Image** – means print, video or recording.

Negligence – Conduct that falls below the standards of behaviour established by law for the protection of others against unreasonable risk of harm.

Waive - to give up (a claim or right e.g.) voluntarily.

Waiver, release and indemnity

In consideration of my participation in the filming, photography and/or recording activity ("the activity") organised by Redland City Council ("the Council"), I (for me, my heirs, executors and administrators) agree with the Council that:

- 1. I waive, release and discharge the Council and its respective officers, employees, contractors, volunteers or agents involved in the activity from all claims or causes of action I may have (including for negligence) arising from any injury, loss or damage of any kind suffered by me including personal injury, illness or death and/or loss or damage to any property (in so far as this does not breach the provisions of the relevant Australian Consumer Law) arising either directly or indirectly out of my attendance at or participation in the activity and the use of any resulting recording
- 2. I indemnify and will keep indemnified the Council against all costs, losses or damages arising from or in relation to my attendance at or participation in the activity and the use of any resulting recording

Images and recordings

- 3. I consent to the Council, its employees, officers, agents and contractors:
 - a. Making images and recordings, whether sound, digital or otherwise ("recordings") of me; and
 - b. Using, publishing or reproducing the resulting recordings and images in any form (in whole or part) and by any medium including but not limited to social media websites, other internet sites, print media, television advertisements, and promotional videos; and
 - c. Doing any and all acts or omissions which would otherwise be an infringement of my moral rights as a performer.
- I acknowledge that the recordings may be used by the Council and other parties for any purpose including but not limited to, public relations, promotions, commercial and advertising purposes ("promotional materials").
- 5. I acknowledge that the recordings and associated information may be stored in an image library for future use by Council and other parties.
- 6. I agree that this consent will continue until I revoke such consent by providing written notification to Council. Despite this, if at the time I revoke consent, Council or any other party is using the recording of me or has entered into contractual obligations in relation to that recording, the consent will continue in relation to that recording until the use or the contractual obligations come to an end.
- I acknowledge that I will not receive any payment, royalty or other consideration (whether monetary or otherwise) from Council in connection with the making, use or storage of the images and recordings.
- 8. I consent to Council collecting, storing, handling, accessing, managing, transferring, using and disclosing personal information about me including but not limited to names, details and image, in connection with the recordings or the promotional materials. This consent is granted subject to any conditions and limitations indicated in this form.
- 9. I acknowledge and agree that any promotional materials which refer to me directly or indirectly, are, at the date of publication, made in good faith and are not intended to defame or offend any person.
- 10. I agree that Council is the owner of the copyright in the recordings and the physical images and recordings.
- I acknowledge and agree that Council may publish my image on Council social media sites including but not limited to Facebook, Twitter, Instagram and Flickr.
